If you are pursuing an Academic or Merit-Based scholarship then we still require a *completed* Financial Aid application. Once we have received **all** required documents for the Financial Aid forms, the Admissions application, and your child(ren) has completed the entrance exams and the interview then the Administration will schedule a meeting with the Financial Adviser to discuss Financial Aid and Scholarship options. Please understand that Financial Aid and Scholarships are *not guaranteed* and the **availability is extremely limited**. Families and students must qualify to receive.

Financial Aid, Merit-Based, & Academic Scholarships are applied to **TUITION ONLY**. There are no discounts on any fees. All fees are due at the time of registration as well as all post-dated checks required to cover the entire year's balance. Students will not be accepted to class until all requirements have been satisfied.
